

# Enhancing Maternal Health Outcomes Through Integrated Care for Women of Color

Research shows that discrimination and racial injustice have a significant impact on maternal mortality rates among people who identify as women of color. Studies have also shown that women of color are disproportionately impacted by maternal mortality and negative whole-person health outcomes,, with factors such as implicit bias, unequal access to health care services, socioeconomic disparities, and systemic racism playing a role in these disparities.

Dr. Ereme is passionate about women's health and reproductive justice especially as it relates to women of color. She incorporates advocacy into her career to help advance those objectives. Her research focuses on health disparities and centers people of color. She is a fellow of the Physicians for Reproductive Health, Leadership Training Academy, class of 2023. She is also the host of the podcast, The Oshun Project: Speaking Justice to Reproductive Health, which centers people of color and aims to educate, and advocate for reproductive iustice.

#### Saleemah McNeil



My name is Saleemah J. McNeil, I am the Founder and Executive

Director of Oshun Family Center, a Reproductive Psychotherapist, certified lactation consultant, a retired birth doula, maternal health researcher, adjunct professor, and maternal health advocate. I sit on a host of committees and boards to advance maternal health such as the maternal mortality review committee and a partner of the Black Mamas Matter Alliance. Additionally, I am the curator of the Maternal Wellness Village, a Philly-based collective of Black birth workers that directly serve the community and serve as content area experts to boards, institutions, and legislators. And lastly, I am published! I am a co-author of an article that will be published in fall 2023 in the Green Journal from the American College of Obstetrics and Gynecology! I have personally and professionally contributed to the community by providing equitable, racially concordant direct services to members of the Black community to address concerns regarding the intersection of racism and maternal health, perinatal mood and anxiety disorders, and trauma. Maternal morbidity & mortality is a public health crisis, therefore working to improve the experiences of Black birthing families, will ultimately impact their overall quality of life.


