Dear Chair Aderholt, Ranking Member DeLauro, Chair Baldwin, and Ranking Member Capito,

Thank you very much for your continued dedication, diligent efforts, and steadfast support in continuing to work towards strengthening access to lifesaving and crucial mental health and substance use services for individuals and families in communities across our country. While we are attentive to the realities of the current funding environment, continued investments in mental health and substance use services are critical to ameliorating the complex mental health, substance use, and workforce shortage crises we face today.

Maintaining, and increasing where possible, investments in mental health and substance use services not only mitigates the serious, personal costs to individuals and families in our country, but it also supports staving off financial costs in other areas. One study has shown that for every dollar invested into early care and treatment for mental health and substance use challenges, there is a \$2-\$10 return in savings on health, criminal justice, education, and economic costs.<sup>1</sup>

We, the undersigned, are writing to you now to strongly urge you to include funding in the final fiscal year (FY) 2025 Labor, Health and Human Services, Education, and Related Agencies appropriations bill at the following levels:

- \$400M (+\$15M over FY 2024) for Certified Community Behavioral Health Clinics (CCBHCs), as proposed by the Senate
  - We also strongly urge the adoption of the Senate proposed report language that directs SAMHSA to consider and advance CCBHC independent accreditation and the CCBHC data infrastructure and repository initiative to further transparency and accountability.
- \$27.96M (level over FY 2024) for Mental Health Awareness Training (MHAT), as proposed by the Senate
  - We also strongly urge the adoption of the Senate proposed report language that highlights support for training for first responders to recognize the signs and symptoms

of mental health challenges as well as encouragement to prioritize grantees where there is a high prevalence of youth substance use disorders.

- \$55.877M (level over FY 2024) for Primary and Behavioral Health Care Integration (PBHCI) Grants and \$2.991M (level over FY 2024) for PBHCI Technical Assistance, as proposed by both the House and Senate
- \$2.508B (+\$500M over FY 2024) for Substance Use Prevention, Treatment, and Recovery Services Block Grant (SUPTRS BG), as proposed by the House
- \$1.042B (+\$35M over FY 2024) for Community Mental Health Service Block Grant (MHBG), as proposed by the Senate
